Introduction:

Communication:

Information we share:

For how long do we store your personal data?

We store your data as long as it is necessary to perform our agreed commitments to you and as long as required by statutory storages times.

Your rights to access, correct and delete personal information:

- Right to access your data You can request a copy (also called a registry extract) and verify the information we have about you. It is free to request a copy, however, if the right to a registry extract is abused, we will charge you for the administrative costs.
- Correction You are entitled to correct incorrect or incomplete information about yourself.
- “The right to be forgotten” You are entitled to request removal of your personal information for those cases where the information is no longer necessary for the purpose for which it was collected. However, there may be legal obligations that prevents us from immediately deleting parts of your data. In such cases, we block the data that we are required to save, from being used for purposes other than complying with such legal obligations.
